**EXPLANATORY NOTE**

**WHEREAS**, the City Government of Vigan has acquired a delivery van for the purpose of transporting of carcasses of hogs and cattles from the Vigan Slaughterhouse to Vigan Public Market;

**WHEREAS**, there is a need to establish rates for the fees to be collected and guidelines for the use of the delivery van;

**WHEREAS**, the use of the delivery van in transporting meat products from the Vigan Slaughterhouse to the Vigan Public Market will be an efficient and effective method in ensuring the safe and good quality of meats for human consumption;

**WHEREFORE**, the Sangguniang Panlungsod in session duly assembled to enact;

**SECTION 1. Title - “AN ORDINANCE ESTABLISHING RATES OF FEES AND GUIDELINES FOR THE USE OF DELIVERY VAN IN TRANSPORTING CARCASSES OF HOGS AND CATTLES FROM THE VIGAN SLAUGHTERHOUSE TO THE VIGAN PUBLIC MARKET.”**

**SECTION 2. Imposition of Fees** – There is hereby imposed a fee for the use of the delivery van of Vigan City as follows:

HOGS	–	P 25.00/head
CATTLE	-	P 30.00/head

**SECTION 3. Administrative Provisions:**

1. The Slaughterhouse Master or his duly authorized representative shall be responsible in the implementation of this Ordinance and shall have direct supervision in the collection of fees herein provided.
2. Fees shall be paid before carcasses of hogs and cattles are placed in the delivery van for transport.
3. This Ordinance shall form part of the Vigan City Revenue Code.

**SECTION 4. Accrual of Fees** – Income from the operation of the delivery van shall accrue to the General Fund. Available funds thereafter shall subsequently be used primarily for the maintenance and care of the delivery van and for various slaughterhouse projects.

**SECTION 5. Authority of the Office of the City Mayor** – The Local Chief Executive shall be authorized to promulgate policies and guidelines for the effective implementation of this Ordinance and adjustment of rates as the need arise. She is likewise authorize to allot available funds from whatever source for the operation and maintenance of the delivery van.

**SECTION 6. Penalty Clause** – Carcasses of hogs and cattles which shall not be transported through the delivery van shall not be allowed to be sold in the Vigan Public Market

**SECTION 7. Repealing Clause** – All existing ordinances, resolutions, motions or parts thereof not consistent herewith are hereby repealed, amended or superseded accordingly.

**SECTION 8. Effectivity** – This Ordinance shall take effect upon approval and publication in accordance with law.
