**Ordinance No. 3**  
**Series of 1999**

**“AN ORDINANCE REGULATING THE CARRYING OF FIREARMS CONCEALED OR OPENLY, IN ALL OFFICES IN THE MUNICIPAL BUILDING OF VIGAN, ILOCOS SUR.”**

**SECTION 1.** Be it ordained by the Sangguniang Bayan of Vigan in session that the carrying of firearms covered by permit / license, concealed or openly, in all offices in the municipal building of Vigan, Ilocos Sur, shall be regulated.

**SECTION 2. SCOPE AND LIMITATION**

- 2.1. Persons carrying firearms desiring to enter into any office / offices in the Municipal Building of Vigan, Ilocos Sur, shall deposit for safekeeping said firearms covered by permit / license, to the PNP Desk Officer of the PNP Vigan Station.
- 2.2. Such deposited firearms shall be issued corresponding receipts to the depositors (owners) by the PNP Desk Officer. Said receipts issued shall be surrendered to the PNP Desk Officer when the depositors (owners) shall claim the firearms deposited.
- 2.3. That a logbook for the firearms deposited under the custody of the PNP Desk Officer shall be made available to contain the following information:
  - a. Name of the depositor / owner
  - b. Mark or Caliber
  - c. Serial Number
  - d. Ammunition (if any)
  - e. Time deposited and withdraw or claim
  - f. Signature of the depositor
- 2.4. That there shall be made available an “unloading wooden box” measuring 2” x 2” with a depth of 4” filled with sand.
- 2.5. That a cabinet / drawer be made available where the deposited firearms be kept for safekeeping.
- 2.6. Reminders for the depositing of firearms at the PNP Desk Officer be legibly and conspicuously posted at the entrances of the ground floor of the Municipal Building, (infront and at the back passages).

**SECTION 3. EXEMPTIONS**

- 3.1. The Office of the PNP Vigan Station located within the Vigan Municipal Building.
- 3.2. Authorized close in security officer/s of the Chief Executive of Vigan and the members of the Sangguniang Bayan including the ex – officio members and VIP Dignitaries with official business in the

Municipal Building with prior coordination or clearance from the duly designated officer of the Vigan PNP.

**SECTION 4. PENALTY**

4.1. Violation of Section 2.1. shall be penalized with fine of first offense Three Hundred Pesos (P300.00); second offense Five Hundred Pesos (P500.00) and third offense One Thousand Pesos (P1,000.00) and commendation for revocation of permit / license and the filing of an Administrative Case, in the case of a government employee and those in the government service.

**SECTION 5. EFFECTIVITY** – This ordinance shall take effect upon its approval.
