“AN ORDINANCE REQUIRING ALL BARANGAY COUNCILS OF VIGAN CITY TO HAVE THEIR OWN DRY SEAL”

SECTION 1. Title. This shall be known as the “Barangay Councils Dry Seal Ordinance”

SECTION 2: Definition of Term.

Seal – it is an instrument or a device affixed to a document as a proof of authenticity.

SECTION 3. Coverage. This ordinance shall cover all barangays within the territorial jurisdiction of the City of Vigan.

SECTION 4. Applicability. All Barangay Councils of the City of Vigan are required to have their own dry seal. The seal shall be affixed to documents or any written communications such as solicitation envelopes, letters, resolutions, ordinances, petition and other similar forms emanating from the barangay councils.

SECTION 5. Penalty. Any document or communication emanating from the barangay without seal stamped/affixed on it shall not be honored nor entertained.

SECTION 6. Amendatory/Repealing Clause. Any existing ordinance contrary to the provisions hereof is hereby amended, repealed and modified accordingly.

SECTION 7 Separability Clause. If any provision of this ordinance, or the application of such provisions to any persons or circumstances is declared unconstitutional by the court of competent jurisdiction, the remaining provisions to other persons or circumstances shall not be affected by such declaration.

SECTION 8. Effectivity. This ordinance shall take effect upon approval.
